### **Allowable Time to Complete the Program:**

6 months from date of registration

#### **How to Request an Extension**

After six (6) months, the student can request an extension of three (3) additional months to complete the program by sending an email to <a href="mailto:DementiaCareAcademy@DementiaSolutions.ca">DementiaCareAcademy@DementiaSolutions.ca</a>

Please note: There is a minimal admininistrative fee of \$ 25 (plus applicable taxes) that the student needs to pay before access can be granted.

After payment of the administrative fee, the student will be given access and additional three (3) months to complete the program. If after the three (3) months' extension, they have not completed the program, the student will not be granted any further extensions. They will instead be required to re-register and restart the program from the beginning as a new student. This policy is in place to encourage students to stay courrent with their knowledge and skills in dementia care.

### Money Back Guarantee & Refund Policy:

If after completing the <u>first 3 modules, and before progressing any further</u>, the student feels as if they are not receiving any value from the program <u>AND</u> provided that their request was received <u>no-more than</u> <u>thirty (30) days</u> from the date of registration, they can request a full refund.\*\*

### \*\*How to Request a Refund
